Advocacy

Governor Kathy Hochul

- Gov. Hochul proclaimed March 5 11, 2023 School Social Work Week (Proclamation available on website.)
- Gov. Hochul's 2023 "Back to School" visit included one of NYSSSWA Board member's schools.



Mental Health Association in New York State (MHANYS)

- Networked with other local and state organizations.
- Discussed resources available to SSWs and school staff.
- MHANYS's Western group provided a joint presentation in May to Buffalo Region SSWs



New York General Assembly

- NYSSSWA met with legislators throughout the year to advocate for increased School Social Workers and services to students.
- NYSSSWA participated in last year's "Advocacy Day".
- o The Board accepted the invitation to Senator Andrew Gounardes' and Assembly Member Jo Anne Simon's event to support their Lockdown Drill Reform bill.

New York State Education Department—NYSED

- o Continued ongoing discussions and SSW advocacy with Evan Seiden, Executive Secretary to clarify the regulations for obtaining supervision in the school setting to obtain licensure.
- NYSSSWA Committee continues to meet to develop documents that will outline step by step procedures for receiving supervision in schools in order to obtain an LCSW.



Student Centered Support Services (SCSS) - "The Collective Care Team"

- o Attended quarterly meetings held with the presidents of NYSSCA, NYASP and NYSASN (State associations for School Counselors, School Psychologists & School Nurses).
- o Group is working to narrow legislative focus as well as strategies to advocate jointly as a team on issues impacting services to students.
- o Group reached out and obtained lobbying support from the New York State United Teachers (NYSUT)
- o On May 7, 2024, NYSSSWA joined our "Collective Care Team" members for Advocacy Day hosted by NYSUT to meet with Senators and Assembly staff to advocate for (4) bills that were currently in the legislature.
